No manufacturer's warranty covers its powertrain for more miles than Suzuki. This means that the engine, transmission and drive system, the primary components that get you from one place to another, are covered for 100,000 miles! That's 40,000 miles farther than Toyota and Honda, brands with good reputations for quality, but with much higher price tags. Hyundai, Kia, and Mitsubishi match our 100,000-mile powertrain warranty, but their warranties are not transferrable and no one beats us on miles covered.

No deductible

All warranty repairs are covered at no charge for parts and labor.

Roadside Assistance

Quality is designed into every Suzuki. But things happen. Out of gas? Got a flat tire? Locked out of your vehicle? Need a jumpstart? Need a tow to your nearest Suzuki dealer? No worries. Suzuki's got you covered with its 3-year, 36,000-mile Roadside Assistance Program. You can rest assured that you will not be stranded during this period. Toyota, Honda, and Nissan do not provide a Roadside Assistance Program.

BETTER RESALE VALUE

Fully transferable

All Suzuki vehicle warranties are fully transferable with no transfer fees to the next owner. In fact, Suzuki has the longest transferable powertrain warranty of any key competitor! This means better resale value, since you can pass this benefit on to the next owner when you sell or trade in your Suzuki. Second owners of a Hyundai, Kia, or Mitsubishi do not get this peace of mind. As a new car customer, their 100,000-mile powertrain warranty may match ours, but their coverage ends when the car is sold.

2006 NEW VEHICLE LIMITED WARRANTY COMPARISON

BASIC WARRANTY

Suzuki's New Vehicle Limited Warranty covers almost all components of the vehicle for 3 years or 36,000 miles, whichever comes first. There is no deductible and the warranty is fully transferable.

POWERTRAIN LIMITED WARRANTY

At 7 years or 100,000 miles with full transferability and no deductible, you can see why it's called America's #1 Warranty. While Hyundai, Kia, and Mitsubishi offer longer powertrain warranty durations, their powertrain warranty is not transferable to the next owner and their mileage limitation is the same as ours. This means that if you drive more than 14,285 miles per year or intend to sell or trade in your vehicle within 7 years, the Suzuki warranty is a better warranty for you.

2006 NEW VEHICLE LIMITED WARRANTY COMPARISON

CORROSION PERFORATION LIMITED WARRANTY

Suzuki's Corrosion Perforation Warranty has got you covered for 3 years, regardless of mileage. There is no deductible and the warranty is fully transferable. Corrosion perforation is defined as "body sheet metal panels that develop perforation due to corrosion."

¹ If corrosion does not cause perforation (holes), and is not the result of usage and/or environmental conditions, paint damage is covered under the terms of the bumper-to-bumper warranty (3 years or 36,000 miles, whichever occurs first). For damage caused by airborne material (environmental fallout)—where there is no factory-related defect involved and therefore no warranty—policy is to cover paint damage due to airborne material for 12 months or 12,000 miles, whichever occurs first.

² Rust that does not perforate, but is caused by a defect in material or workmanship, is covered under the New Vehicle Limited Warranty.

³ For sheet-metal panels, the limit is 36 months, with no mileage accumulation. For an outer-body sheet-metal panel—one that is finished-painted and that is visible when walking around the vehicle—the limits are 5 years or 100,000 miles on the odometer, whichever occurs first.

⁴ Corrosion other than perforation (hole through the body panel), due to defects in material or workmanship, is covered under the New Vehicle Limited Warranty.

⁵ Outer panel rust-through protection is extended as follows: New 2006 vehicles are covered for 7 years or 100,000 odometer miles, whichever occurs first.

⁶ Body sheet metal panels are covered against rust for 3 years or 36,000 miles, whichever comes first.

⁷ Applies to any original body panels that develop perforation from corrosion (rust-through).

ROADSIDE ASSISTANCE

All new Suzuki vehicles are covered by **Roadside Assistance** during the 3-year or 36,000-mile New Vehicle Limited Warranty period, available 24 hours a day, 365 days a year, in the U.S. and Canada. Available services include tire changes, jumpstarts, lockout service, minor mechanical repairs and towing to the nearest Suzuki dealer or authorized service center. Toyota, Honda, and Nissan do not offer Roadside Assistance.
